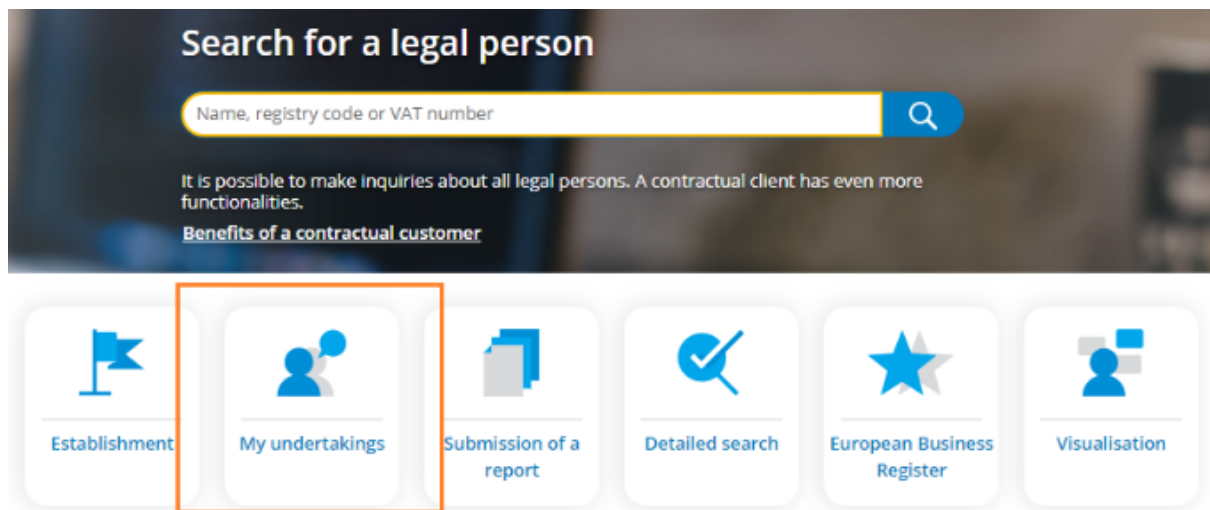




Viewing data of a legal person related to you

The data of a legal person related to you can be viewed by entering the e-business register as a natural person with your ID card / mobile ID or Smart-ID (it is not possible to sign annual applications with smart ID) here: <https://ariregister.rik.ee/eng>

After logging in, press the "My Undertakings " button on the home page.
